We have appointed Alliance Knowledge Management Limited to handle all issues regarding captioned subject. After consulting to our consultant we have following procedure to implement the new RAR requirements.

Regulated Agent Security Program

After consulting to our consultant we have following procedure to implement the new RAR requirements. Our management reviews our air operation activities and designed new arrangements to fit the new requirements, those information reflected on attached new REGULATED AGENT SECURITY PROGRAM. We also contacting our business partner (Shippers, co-loaders and contractors) regarding to the new requirements.

We will prepare an "Internal Security Procedure for RA" to strengthen the communication internally and clearer the responsibilities for different operation procedures which targeted to be completed by 3 months.

Training Requirement

We appointed Alliance Knowledge Management Limited as our internal trainer and we will arrange our staff to attend their Professional Level Up Training - Security Awareness Training within 3 months.

Internal Audit

Alliance Knowledge Management Limited will perform internal audit within 6 months. The results of each self-assessment shall be maintained for 3 years and be available for the announced and unannounced inspections by Civil Aviation Department.
